Product overview

The Distintivo Scuola Polizia Tributaria Guardia di Finanza is an enamelled metal badge issued for members of the Guardia di Finanza who serve in the Scuola Polizia Tributaria. It is intended for duty wear by authorized personnel and for verified collectors with the required license.



Definition: this is an enamelled metal uniform badge showing a soldier with a helmet and the wording "Scuola Polizia Tributaria." Availability is limited and sale requires identity verification.

Main features

Clean, durable construction and official markings identify this badge as a duty item for tax, economic and financial investigation units.

- **Material:** Enamelled metal for long-lasting finish and corrosion resistance.
- **Design:** Shield-shaped enamel background depicting a helmeted soldier with the inscription "Scuola Polizia Tributaria."
- **Attachment:** Rear pin fastener for secure mounting on uniform.
- **Authorized use:** Intended for members of the Guardia di Finanza and verified collectors only.
- **Verification required:** Sale and shipping occur only after identity verification or presentation of the prefettizia license (ex art. 28 TULPS) for collectors.
- **Relevant for:** tactical/duty uniforms, police and military surplus collectors, and official display.

How to use / When it's useful

Quick answer: wear it on the uniform according to Guardia di Finanza regulations or add it to a verified collection. The badge is used by units specialized in tax, economic and financial investigations.

In most cases, it is shipped only after you provide a copy of your military ID or register the delivery to your Command location; collectors must send the prefectural license required by law. It is useful for official duty identification, ceremonies, or authenticated military surplus displays.

Care and notes

Keep the badge clean and store it safely when not in use; handle identification and shipping requirements carefully to avoid delays.

- Wipe with a soft cloth; avoid abrasive cleaners to protect the enamel.
- Store in a dry place to prevent corrosion of the metal parts.
- Sale and shipment require proof of belonging to the Guardia di Finanza or a valid prefettizia license for collectors.
- Do not wear or display the badge in official contexts unless you are authorized to do so.

FAQ

Q: Who can purchase the Distintivo Scuola Polizia Tributaria Guardia di Finanza?



A: Sales are restricted to members of the Guardia di Finanza and to collectors who provide the required prefettizia license (ex art. 28 TULPS). Verification is required before shipping.

Q: How is the badge shipped?

A: The badge is shipped only after identity verification. Members can send a copy of their military ID or register the delivery address as their Command headquarters.

Q: What are the main material and attachment details?

A: The badge is made of enamelled metal and uses a rear pin fastener for secure attachment to the uniform.

Q: Can a civilian buy this badge without documentation?

A: No. Civilians must be verified collectors with the prefectural license required by law; otherwise purchase is not permitted.

Q: How can I verify the badge's authenticity?

A: Authenticity is ensured through the mandatory verification process at purchase, which requires a copy of the military ID or the collector's prefettizia license.

Q: Is this badge suitable for display or tactical/military surplus collections?

A: Yes. Once legally obtained and verified, the badge is suitable for authenticated military surplus collections or official display, and for authorized uniform use by Guardia di Finanza personnel.
