## Product overview

The Distintivo Banda Musicale Guardia di Finanza is a metal enamel badge for members of the



Banda Musicale of the Guardia di Finanza and for authorized collectors. It is intended for uniform use, ceremonial duty, or as a collectible military surplus item.

Definition: a 32 x 45 mm metal enamel shield badge with a rear pin, featuring a green background, a musical lyre and the inscription "BANDA MUSICALE". This badge is reserved for Corpo personnel or collectors with the required documentation.

### Main features

Simple, durable design made for uniform wear and official appearance; useful for duty, ceremonial, or collection purposes in tactical, military surplus, and police contexts.

- **Elegant design:** Sannitic shield with green Guardia di Finanza background, a musical lyre and the wording "BANDA MUSICALE".
- **High-quality materials:** Metal construction with enamel finish for long-lasting appearance.
- **Compact size:** Measures 32 x 45 mm—visible but not bulky on the uniform.
- **Rear pin attachment:** Secure pin fitting for easy application and removal.
- **Reserved distribution:** Available only to Banda Musicale members or licensed collectors under documented rules.

### How to use / When it's useful

Wear the badge on the uniform where insignia are normally placed for musical band members during parades, ceremonies, and official duty. Collectors display it in cases or on uniform replicas with appropriate documentation.

Quick answer: wear it on the uniform using the rear pin or keep it in a collector display. In most cases, purchase requires proof of service or a prefectural license for collectors (art. 28 TULPS).

### Care and notes

Keep the badge clean and handle the pin with care to preserve the enamel and attachment. Observe the documentation requirements before ordering.

- Store in a dry place and clean with a soft, dry cloth; avoid strong chemicals.
- Ensure the pin backing is secure before wearing on any uniform fabric.
- Sale is subject to verification: active members must send a copy of their tesserino or use their barracks as the delivery address.
- Collectors must provide a copy of the prefectural license in accordance with art. 28 TULPS.

### FAQ

**Q:** Who can purchase the Distintivo Banda Musicale Guardia di Finanza?



**A:** Only current members of the Banda Musicale and collectors who supply a valid prefectural license (art. 28 TULPS) can purchase this badge. Proof is required at the time of order.

**Q:** What are the badge dimensions?

**A:** The badge measures 32 x 45 mm. It is designed to be visible on the uniform without being oversized.

**Q:** How do I prove my membership to buy the badge?

**A:** Provide a copy of your service tesserino showing membership, or set the barracks address as the delivery location during registration to confirm service.

**Q:** Can collectors buy this badge?

**A:** Yes. Collectors must submit a copy of the prefectural license required by art. 28 TULPS to qualify for purchase.

**Q:** How is the badge attached to the uniform?

**A:** The badge uses a rear pin attachment for straightforward application and removal. Always check the pin is fastened properly to avoid loss.

**Q:** Is availability limited?

**A:** Yes. The badge is distributed under restricted conditions and stock may be limited. Orders are processed only after required documentation is verified.

**Tip:** Choose the correct badge and prepare required documentation before ordering; consider browsing related military surplus and duty insignia to complete a uniform or collection.
