How to use / When it's useful

Quick answer: Attach the cordoniera inside the robe sleeve and adjust the length so the cord sits comfortably and securely during court appearances. The cord is meant to be a discrete interior detail rather than an external accessory.

In most cases, lawyers use this cordoniera when wearing formal toga for hearings, ceremonies, or official duties where a regulation-compliant appearance is required. It helps keep the sleeve tidy while adding a traditional, professional finish to court attire.

Care and notes

Simple care will keep the cordoniera looking its best; handle gently when adjusting and store with your robe to prevent tangling.

- Spot clean only where necessary; avoid aggressive washing to protect canutiglia thread.
- Adjust length carefully to avoid strain on attachment points inside the sleeve.
- Product is made to the Ordine Forense production standards.



- Limited availability: demand may be high, so consider ordering early.

FAQ

Q: Is the cordoniera suitable for all types of togas?

A: Yes. The cordoniera is adjustable in length and designed to adapt to most standard lawyer robes. Adjust it to the sleeve size for a correct fit.

Q: How is the cordoniera fixed to the toga?

A: It is secured inside the sleeve of the robe, providing a stable and discreet attachment that stays in place during normal use.

Q: Is the canutiglia thread durable?

A: The silver-and-black canutiglia thread used is chosen for durability and appearance. With careful handling it will retain its look over time.

Q: Are other colors available?

A: Currently this cordoniera is offered in silver-and-black canutiglia thread only, chosen for its traditional and professional appearance.

A: Check that your robe sleeve allows for an internal cord and be aware of limited stock. Order ahead if you need the cordoniera for a scheduled court appearance.
