This tailored Toga Avvocato Magistrato Giudici is a courtroom robe designed for lawyers, magistrates and judges for official hearings and judicial proceedings. It combines traditional formal style with precise tailoring for professional use.

Definition: A court robe worn by legal professionals to signal authority and respect during trials, council meetings and formal court sessions. Made with quality fabrics and silk facing for a refined appearance and comfortable fit.

Main features

Key design and production details that matter for fit, appearance and personalization.

- **Sartorial design:** Two open lapels with a silk facing (mostratura) edged by a decorative band.
- **Sleeve finish:** Sleeves hemmed with a 10 cm band for a refined look.
- **Personalization:** Option to add an embroidered name label for individual identification.
- **Measured fit:** Robe length is taken from the neck to approximately mid-calf for a tailored fit.
- **Production time:** Made to order in about 15–20 working days after measurements are received.
- **Limited availability:** Produced in controlled quantities due to bespoke tailoring demand.

How to use / When it's useful

Quick answer: Wear this robe for court hearings, sessions before the Corti, meetings with the Bar Council and appearances before the Consiglio Superiore Forense. It is suitable wherever formal legal attire is required.

In most cases, order the robe with your exact measurements and request the embroidered name label if needed. Plan ahead for the 15–20 working day production time to ensure delivery before important hearings or official duties.

Care and notes

Simple care guidance and practical notes to ensure correct fit and timely delivery.

- Measure length with a tailor's tape from the neck to mid-calf for accurate sizing.



- Provide the name exactly as you want it for embroidered labels; errors may delay production.
- Allow 15–20 working days for bespoke production after measurements are confirmed.
- Follow the garment care label or choose professional cleaning suited to silk-trimmed items.
- Limited stock: order early if you need the robe for a scheduled hearing.

FAQ

Q: What materials are used for the robe?

A: The robe is made with high-quality fabrics and includes a silk facing (mostratura) as part of its trimmed design.

Q: Can I personalize the robe with my name?

A: Yes. You can add an embroidered name label by filling in the name field when placing the order. Provide the exact spelling to avoid delays.

Q: How long does it take to receive the robe?

A: Production time is approximately 15–20 working days from the moment your measurements are provided. Shipping time is additional.

Q: How do I measure the length of the robe?

A: Measure with a tailor's tape from the base of the neck down to about mid-calf. This ensures the robe matches traditional court length requirements.

Q: Is this robe suitable for all court appearances?

A: Yes. The robe is designed for use in tribunals, courts, before bar councils and the Consiglio Superiore Forense whenever formal legal attire is required.

Q: What should I know before ordering?

A: Ensure your measurements are accurate and confirm any personalization text. Custom production and limited availability mean it's best to order well before any planned hearing.
