Product overview

The Berretto Maschile Guardia di Finanza is an official men's duty cap reserved for members of the Guardia di Finanza and licensed collectors. It is a non-regulation model made in anthracite grey gabardine that combines formal appearance with practical build quality.



Definition: a military-style duty cap designed for Guardia di Finanza personnel and verified collectors. This cap suits military, police and tactical use as a dress or duty accessory.

Main features

Solid construction and traditional details give this cap a professional look while remaining durable for regular wear.

- **Outer material:** anthracite grey gabardine for durability and a neat finish.
- **Interior finish:** fitted with a marochino leather sweatband for comfort during extended wear.
- **Visor:** natural leather visor, painted black on top and lined in black inside.
- **Chinstrap and buttons:** glossy black strap secured at each end by two gold-coloured metal buttons bearing the Guardia di Finanza emblem.
- **Decorative band:** grey pearl millerighe band under the lining for a refined appearance.

How to use / When it's useful

Quick answer: wear this cap as part of Guardia di Finanza duty or dress occasions, or as a verified collector item where allowed. It is a suitable military cap for formal and ceremonial use as well as everyday duty when authorized.

In most cases, members should have the cap delivered to their unit or supply verification at checkout. Collectors must present the required prefectural license to complete the purchase and delivery.

Care and notes

Simple care preserves appearance and leather parts; follow these practical notes before use.

- Do not machine wash; clean fabric with a soft brush and spot-clean the leather visor with a damp cloth.
- Store in a cool, dry place and keep the cap shaped to avoid creasing the crown or visor.
- Sales restricted: purchase requires submission of military ID proving membership or delivery to the serving Command's address; collectors must provide the prefectural license (ex art. 28 TULPS).
- Availability is limited due to restricted distribution to Guardia di Finanza personnel and licensed collectors.

FAQ

Q: Who can buy the Berretto Maschile Guardia di Finanza?

A: Only active members of the Guardia di Finanza and collectors who hold the prefectural license



(ex art. 28 TULPS) are permitted to purchase this cap.

Q: What materials are used in the cap?

A: The cap is made from anthracite grey gabardine with a marochino leather sweatband and a natural leather visor painted black.

Q: How do I provide proof of eligibility to buy?

A: During checkout you must upload a copy of your military ID or set the delivery address to your Command of service. Collectors must upload their prefectoral license.

Q: Is there a size guide for the cap?

A: Yes, a size guide is available on our website to help you choose the correct head size. Select carefully to ensure a comfortable fit.

Q: Can I return the cap if it does not fit?

A: Return and exchange policies apply as stated at checkout; returns may be limited for restricted items—check the product terms before purchase.

Q: Is this cap suitable for tactical or everyday duty use?

A: The cap is intended as a duty/dress cap for Guardia di Finanza personnel and as an item for verified collectors; use in tactical operations depends on unit rules and authorizations.
