The Distintivo Scuola Ispettori Sovrintendenti Guardia di Finanza is the official badge for Inspectors and Superintendents of the Guardia di Finanza who have completed the non-commissioned officers training school. This badge serves as a formal insignia of achievement and belonging within the corps.

Definition: an official duty badge awarded to personnel who have passed the Guardia di Finanza subofficers training course. The item is intended for military/tactical use, collectors with proper authorization, and as a duty or ceremonial insignia.

## Main features

- **Size:** 2.9 x 3.5 cm — compact and visible without being bulky.
- **High-quality materials:** Made to last under normal wear; designed for regular duty or display.
- **Official design:** Styling reflects the professional identity of the Guardia di Finanza.
- **Sale restricted:** Available only to Guardia di Finanza personnel and authorized collectors.
- **Verified authenticity:** Purchase requires proof of membership or service location on file.

## How to use / When it's useful

Quick answer: Wear the badge on the uniform or keep it as an official memento after completing the qualifying course. It identifies trained Inspectors and Superintendents and can be used for formal duty, ceremonial occasions, or authorized collections.

In most cases, the badge is supplied to active Guardia di Finanza personnel after verification. Collectors may purchase only if they provide the required prefectural license under art. 28 TULPS; otherwise the item is not available to the general public.

## Care and notes

Basic care and important purchase conditions to keep the badge in good condition and comply with rules.

- Store in a dry place and avoid prolonged exposure to moisture or harsh chemicals.
- Sale is reserved to Guardia di Finanza personnel; registration requires proof of membership or the service barracks address.
- Collectors must supply a copy of the prefectural license (art. 28 TULPS) to complete the purchase.
- Limited stock: allow for verification time when placing an order.

## FAQ



**Q:** Who can buy this badge?

**A:** Only active personnel of the Guardia di Finanza and collectors with the required prefectural license (art. 28 TULPS) can purchase this badge. Purchase is subject to verification.

**Q:** What documents are needed to buy?

**A:** You must send a copy of your service ID card proving membership in the Guardia di Finanza or indicate your barracks as the delivery location during site registration.

**Q:** Can collectors purchase the badge?

**A:** Yes, collectors can buy it only if they provide a copy of the prefectural license required by art. 28 TULPS. Orders without proper documentation will not be accepted.

**Q:** What are the badge dimensions?

**A:** The badge measures 2.9 x 3.5 cm. The size is compact for duty wear and suitable for display or collection purposes.

**Q:** Is this badge sold to the general public?

**A:** No. Sales are restricted to Guardia di Finanza personnel and verified collectors with the appropriate license; public sale is not permitted.

**Q:** How is authenticity confirmed?

**A:** Authenticity and eligibility are confirmed by the required documents: a copy of the service ID or the prefectural license for collectors, and the delivery address of the barracks when requested during registration.

**Tip:** Choose the correct option that matches your status (active personnel or licensed collector) when ordering, and consider browsing related tactical, military surplus, and duty items to complete your uniform or collection.
