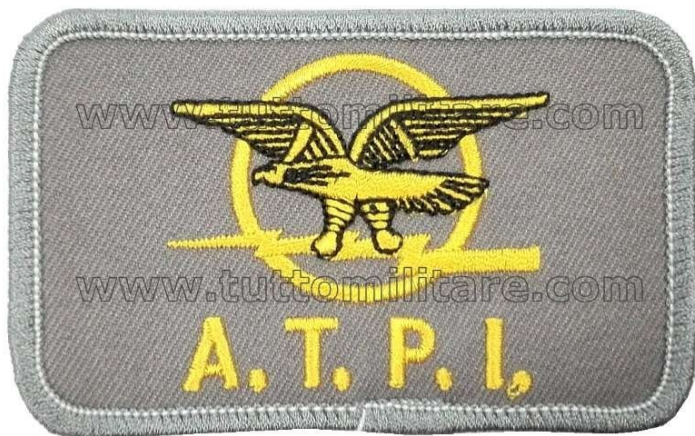

The **Targhetta Ricamata ATPI Guardia di Finanza** is an embroidered identification patch designed for members of the Guardia di Finanza ATPI unit and for licensed collectors. Definition:



it is a velcro-backed embroidered patch showing the ATPI emblem for uniform use or display.

Made for tactical and duty use, the patch features high-visibility yellow embroidery on a grey background and a rear velcro panel for quick attachment to uniforms, jackets, or tactical gear. It suits military surplus collectors, police and duty equipment users, and service personnel.

Main features

Clear, durable embroidery and practical mounting make this patch suited to daily use and collection.

- **High visibility:** yellow embroidered thread on a grey background for immediate recognition.
- **Distinctive design:** eagle in flight clutching a lightning bolt, framed in a round motif.
- **Durable construction:** made with long-lasting materials suitable for regular wear.
- **Velcro backing:** secure and removable attachment for uniforms and tactical vests.
- **Size:** 8 cm width x 5 cm height—visible without being bulky.

How to use / When it's useful

Quick answer: attach the patch to any compatible velcro panel on your uniform or gear for immediate identification. It is ideal for operational duties, escort roles, crowd control tasks, or for display in a collection.

In most cases, the patch is used on uniforms and tactical clothing by ATPI personnel; collectors may keep it in a display case or on a removable backing. Use it where clear unit identification is needed during duty, training, or public order operations.

Care and notes

Basic care preserves the patch's appearance and attachment function; follow service rules for insignia use.

- Attach and remove carefully to avoid stressing the velcro or fabric.
- Store dry and avoid prolonged exposure to heat or abrasive surfaces.
- Sale restricted: purchase requires proof of Guardia di Finanza membership or, for collectors, a prefectural license under art. 28 TULPS.
- Delivery may be set to your command office address as part of verification during checkout.

FAQ

Q: Who can buy the Targhetta Ricamata ATPI Guardia di Finanza?

A: Only Guardia di Finanza members and collectors with a valid prefectural license (ex art. 28



TULPS) are eligible to purchase. Documentation is required at checkout.

Q: What are the patch dimensions?

A: The patch measures 8 cm wide x 5 cm high, designed to be clearly visible while remaining compact on uniforms or tactical gear.

Q: How do I prove my membership in the Guardia di Finanza?

A: You must send a copy of your service ID (tesserino) or provide your command office as the delivery address during registration to verify eligibility.

Q: Is the patch easy to apply and remove?

A: Yes. The velcro backing allows quick, secure attachment to any compatible velcro panel and easy removal when needed.

Q: Can collectors purchase this patch?

A: Yes, collectors may purchase it only if they provide a prefectural license as required by art. 28 TULPS. The same verification process applies at checkout.

Q: Can I wear this on any uniform?

A: The patch represents the ATPI emblem. Members should follow Guardia di Finanza regulations and local service rules for proper placement and authorized use of unit insignia.

Tip: Choose the correct delivery option and prepare the required documents before checkout; also consider browsing related tactical patches and military surplus items to complete your uniform or collection.
