The **Distintivo Cobar Guardia di Finanza** is a metal uniform badge intended for CO.BAR. representatives within the Guardia di Finanza. It is designed for military personnel on duty, authorized representatives, and licensed collectors in the military surplus and tactical community.

Definition: The Distintivo Cobar Guardia di Finanza is a metal duty badge worn by personnel



representing the CO.BAR. council. This badge identifies official representation and service role.

### Main features

Compact, durable and representative, this badge is produced to meet uniform use and identification needs.

- **High-quality material:** Made of sturdy metal for long-lasting appearance and durability.
- **Size:** 2.5 cm width x 3.5 cm length — visible but unobtrusive on the ordinary uniform.
- **Official use:** Worn by CO.BAR. representatives delegated to protect personnel requests and support unit efficiency.
- **Restricted sale:** Available only to Guardia di Finanza members or licensed collectors.
- **Authenticity verification:** Purchase requires proof of membership or a prefectural license (art. 28 TULPS) and correct delivery information.

### How to use / When it's useful

Wear this badge on the ordinary uniform as a sign of CO.BAR. representation and duty. It is suitable for day-to-day official tasks, meetings with personnel, and formal unit duties.

Quick answer: Use it as an identification and representation badge for CO.BAR. delegates while on duty.

In most cases, delivery should be sent to the command headquarters or you must provide a copy of your service ID to confirm eligibility.

### Care and notes

Basic care keeps the metal finish intact; follow the list below for handling and purchase conditions.

- Wipe with a soft, dry cloth; avoid abrasive cleaners or harsh chemicals.
- Store in a dry place to prevent tarnishing or damage.
- Sale requires submission of service ID or a prefectural license (art. 28 TULPS) for collectors.
- Provide the command headquarters as the delivery address when required during registration.

### FAQ

**Q:** Who can purchase the Distintivo Cobar Guardia di Finanza?

**A:** Only members of the Guardia di Finanza and collectors holding a prefectural license (art. 28 TULPS) may purchase this badge. Verification is required before shipment.



**Q:** What are the badge dimensions?

**A:** The badge measures 2.5 cm in width and 3.5 cm in length, designed to be visible on the ordinary uniform without being bulky.

**Q:** What material is the badge made of?

**A:** The badge is made of high-quality metal, chosen for durability and a consistent appearance suitable for duty and formal use.

**Q:** How do I prove eligibility to buy?

**A:** You must submit a copy of your service ID showing affiliation to the Guardia di Finanza, or provide a prefectural license if you are a collector. The delivery address may need to be the unit command.

**Q:** Can collectors buy the badge?

**A:** Yes, licensed collectors can purchase the badge by presenting a valid prefectural license under art. 28 TULPS and completing the verification steps required at checkout.

**Q:** Is this an official uniform item?

**A:** Yes, the Distintivo Cobar Guardia di Finanza is intended for official wear by CO.BAR. representatives of the Guardia di Finanza and is sold under controlled conditions to ensure authenticity.
