## Product short description:

Sabre in the style of the Marescialli of the Guardia di Finanza, featuring a radica (briarwood) handle. Suitable for collectors, ceremonial display, and historical reenactment.

## Product overview

The Sciabola Marescialli Guardia di Finanza Manico Radica is a ceremonial sabre made for members of the Guardia di Finanza and the Scuola Allievi Marescialli. It is intended for service personnel and verified collectors who meet legal purchasing requirements.

Definition: a ceremonial Marescialli sabre with a straight blade and a radica (burlwood) handle,



reflecting the Corps' heraldry and tradition. Suitable for military surplus collectors, tactical display, and duty or police ceremonial use.

### Main features

Well-crafted and historically styled, this sabre combines authentic visual details with practical handling features.

- **Straight blade with heraldic emblem:** blade reproduces the Guardia di Finanza coat of arms.
- **Steel guard:** split into two nearly symmetrical branches for protection and balanced look.
- **Radica (burlwood) grip:** handle with four internal grooves to fit the fingers and improve grip.
- **Metal scabbard with flame emblem:** scabbard bears the Guardia di Finanza flame motif.
- **Traditional ceremonial design:** matches the form used for Marescialli and parallels the infantry non-commissioned officers' sabre.

### How to use / When it's useful

Quick answer: this sabre is primarily for ceremonial duties, parades, official uniforms, and authenticated collections. It is not sold as a general retail item and is intended for personnel or licensed collectors.

In most cases, service members will use it for formal occasions or presentation, while verified collectors may keep it for display or historical study. Purchase is restricted and requires pre-verification of service location and buyer identification.

### Care and notes

Keep the sabre in a dry environment and handle it as a ceremonial piece; routine cleaning and safe display will preserve its finish and emblem details.

- Delivery: approximately 20 working days from payment.
- Sale restricted to Scuola Allievi Marescialli members or Guardia di Finanza personnel; collectors need a copy of the license ex art. 28 TULPS.
- To complete a purchase you must email the Command office where you serve and the buyer's codice fiscale for verification.
- Store the sabre in its scabbard and avoid exposure to moisture or strong impacts.

### FAQ

**Q:** Who can buy the Sciabola Marescialli Guardia di Finanza Manico Radica?

**A:** The sabre is reserved for members of the Scuola Allievi Marescialli and the Guardia di



Finanza. Collectors can buy only after providing the required license (ex art. 28 TULPS).

**Q:** What documents are required to complete the purchase?

**A:** Service members must send the Command office location and the buyer's codice fiscale by email. Collectors must send a copy of their ex art. 28 TULPS license.

**Q:** How long does delivery take?

**A:** Delivery takes about 20 working days from payment to ensure careful finishing and verification before shipment.

**Q:** What are the main physical features of the sabre?

**A:** It has a straight blade with the Corps' heraldic emblem, a two-branch steel guard, a radica handle with four finger grooves, and a metal scabbard with the Guardia di Finanza flame.

**Q:** Can the sabre be customized or ordered in other configurations?

**A:** Currently the sabre is offered only in the standard configuration described. Customization is not available at this time.

**Q:** Is this item legal for collectors outside the Corpo?

**A:** Collectors must present a valid license under ex art. 28 TULPS to purchase; sale to non-verified individuals is not allowed.

**Tip:** Choose the correct option for your status (service member or licensed collector) and verify your documentation before ordering; browse related ceremonial sabres and military surplus items to complete your display or uniform set.
