## Product overview

The Alamari Ufficiali Funzionari Polizia Penitenziaria are hand-embroidered shoulder boards for officers of the Polizia Penitenziaria. They are designed for duty uniforms and formal use,



indicating managerial roles and leadership within the corps.

Definition: a pair of hand-embroidered rank alamari in silver braid on blue cloth, intended for qualified Polizia Penitenziaria personnel and qualified collectors under Italian law.

### Main features

These alamari combine traditional craft with clear rank symbolism for an official, professional appearance.

- **Hand-stitched craft:** silver canutiglia embroidery on blue cloth.
- **Rank symbolism:** two stylized horns denote directive and managerial qualifications.
- **Distinct design:** right piece semi-convex with winged outer edge; left piece semi-concave with stylized olive branch inside.
- **Monogram:** raised RI monogram at the base signals Polizia Penitenziaria affiliation.
- **Size:** 14 cm x 4 cm per piece for balanced, visible placement on the uniform.
- **Availability:** reserved to Polizia Penitenziaria members and certified collectors under legal conditions.

### How to use / When it's useful

These alamari are intended for use on duty and ceremonial uniforms where clear rank identification is required. They are suitable for formal inspections, parades, and official events within the correctional service.

Quick answer: Wear them on the uniform shoulders to show managerial rank. In most cases, purchase and delivery require identification or proof of service; collectors need a prefectural license under art. 28 TULPS.

### Care and notes

Handle these hand-embroidered alamari carefully to preserve the silver braid and cloth. Follow simple care steps and respect legal requirements for purchase.

- Store flat in a dry place to avoid creasing or tarnishing of the braid.
- Spot clean gently; avoid machine washing and harsh chemicals.
- Provide official identification (service card copy or service statement) for purchase and shipment to the correctional facility where you serve.
- Collectors: submit a copy of the prefectural license (art. 28 TULPS) to confirm eligibility.

### FAQ

**Q:** Who can buy the Alamari Ufficiali Funzionari Polizia Penitenziaria?



**A:** Purchases are reserved to members of the Polizia Penitenziaria with proper identification. Collectors may buy only if they provide the required prefectural license under art. 28 TULPS.

**Q:** What are the exact dimensions?

**A:** Each alamaro measures 14 cm x 4 cm. The size is intended to fit standard duty uniforms and remain proportionate on the shoulder area.

**Q:** How are these alamari made?

**A:** They are hand-embroidered using silver canutiglia on blue cloth. The handcrafting gives each piece slight, intentional variations and a high-quality finish.

**Q:** What symbols appear on the alamari?

**A:** The design features two stylized horns indicating directive roles, a stylized olive branch on the left, and a raised RI monogram at the base marking affiliation to Polizia Penitenziaria.

**Q:** How do you verify authenticity when buying?

**A:** Verification requires a copy of the service card, a service statement, or proof of shipment to the correctional facility where you serve. Collectors must show the prefectural license under art. 28 TULPS.

**Q:** Can the alamari be shipped to a private address?

**A:** Standard practice is to require identification and, when applicable, shipment to the correctional facility of service. Specific shipping options depend on verification and legal requirements at the time of sale.
