## Product overview

The Distintivo Metallo Polizia Giudiziaria Guardia di Finanza is a metal duty badge designed for members of the Guardia di Finanza assigned to the Polizia Giudiziaria section and for authorized military collectors. It serves as an official emblem of service, authority and professional identity on uniform and in official duty contexts.

Definition: This is a 3.5 cm metal police judiciary badge reserved for Guardia di Finanza personnel and licensed collectors.

## Main features

Clear, durable construction and restricted availability make this badge suitable for duty use and for verified military surplus collections.

- **High-quality metal:** Built for long-lasting appearance and resistance to wear.
- **Size:** 3.5 cm diameter — visible on uniform without being bulky.
- **Official design:** Styling representative of the Guardia di Finanza Polizia Giudiziaria unit.
- **Restricted sale:** Available only to Guardia di Finanza members and collectors with a prefectural license.
- **Authenticity check:** Purchase requires verification of membership card or presentation of the collector's license.
- **Controlled delivery:** Shipment is arranged to the barracks address or to verified collector locations per regulations.

## How to use / When it's useful

This badge is intended to be worn on the uniform for official duty or kept as part of an authorized military or police collection. It identifies the wearer's role within Guardia di Finanza Polizia Giudiziaria and is suitable for daily duty, ceremonial use, or display in a verified collection.

Quick answer: Wear it on the uniform where regulation badges are placed, or keep it in a secure collection case. In most cases, purchase and delivery require identity verification and a verified delivery address (barracks or licensed collector address).

## Care and notes

Keep the badge clean and store it safely when not worn; follow the rules below regarding sale and delivery.

- Clean with a soft, dry cloth; avoid abrasive cleaners or strong chemicals.
- Store in a dry place to prevent tarnish or damage to the metal finish.
- Sale requires submission of a copy of the service ID card or prefectural license for collectors.



- Delivery is to the barracks where the buyer serves or to an approved address after license verification; home delivery is not permitted without approval.

## FAQ

**Q:** Who can purchase this badge?

**A:** Only active members of the Guardia di Finanza and collectors with a valid prefectural license may buy this badge. Verification is required before sale.

**Q:** What are the badge dimensions?

**A:** The badge measures 3.5 cm in diameter, designed to be visible on the uniform without being oversized.

**Q:** What documents do I need to provide to buy it?

**A:** You must submit a copy of your Guardia di Finanza service ID or, for collectors, a prefectural license. Verification must be completed before shipment.

**Q:** Can the badge be delivered to my home address?

**A:** No. For serving personnel, delivery must be to the barracks listed as the service address. Collectors receive delivery after license verification to an approved address.

**Q:** Is this badge available to everyone?

**A:** No. Availability is limited and controlled to preserve authenticity and compliance with regulations for police and military insignia.

**Q:** How is authenticity ensured?

**A:** Each sale requires identity or license verification and is processed only after documentation is confirmed, ensuring authorized possession.

**Tip:** Choose the correct variant and confirm your delivery address during registration; if you are a collector, have your prefectural license ready. Browse related duty and military surplus items to complete uniform or collection needs.
